Aims:	<p>To enable students to explore the theological and practical dynamics raised by Christian-Muslim encounter.</p> <p>To set the key themes of theology and praxis for Christian-Muslim encounter in an historical context.</p> <p>To theologically resource creative and practical encounters between Christians and Muslims that span a breadth of mission and ministry models of the Church.</p>
Content:	<p>The theological issues explored will typically include an examination of the debates around the nature of scripture and revelation, prophethood, the oneness of God, and the relationship between religion and public life.</p> <p>The practical issues will include different modes of mission in the light of the key theological issues discussed. Thus, community collaboration for the common good, dialogue, scriptural reading, evangelism and conversion, and polemics will all be critically examined.</p>
