# Interdisciplinary Understanding for a Changing Arctic (DurhamARCTIC)

### Annual interim report for Leverhulme Doctoral Studentship programme DS-2017-070

#### Review period: 1 October 2022 – 30 September 2023

Because none of the four students from the first Leverhulme/DurhamARCTIC cohort (October 2018) received funding during this review period, this report only covers the records and accomplishments of the eleven students from the second and third cohorts.

The central cohort-building activity of this period was a 10-day summer school held in northern Norway (and adjacent areas of Sweden and Finland) in August 2023. The summer school was led by the DurhamARCTIC director and associate directors, as well as one of our Norway-based external advisory board members. The summer school provided students an opportunity to learn and share their observations on topics ranging from landscape ecology to Indigenous empowerment, and featured presentations by students and guest lecturers. The summer school was attended by 8 of the 11 currently enrolled DurhamARCTIC students (three had family responsibilities that they could not rearrange), and the four DurhamARCTIC alumni attended as well to lead seminars on post-PhD life. DurhamARCTIC is presently producing a film using footage from the field trip, with the intent of using the film to seed discussion on innovations in interdisciplinary training of PhD students.

The remainder of this report provides details on each of the Leverhulme-funded students enrolled in the programme and highlights some notable achievements during the review period.
