

About 'TheCloud'

Driving to Ushaw on Thursday

<u>Car drivers</u>: If you are driving to Ushaw College on the Thursday, there is plenty of onsite parking. Please enter the College by the Main entrance, take the right-hand fork on the drive to the car park. There is an overflow car park just off the main car park.

Sat-nav users please note: Please use "DH7 7DW" to ensure you are directed the correct way (Using the postcode "DH7 9RH" on your sat-nav will <u>not</u> direct you to the college entrance.) The correct road is marked "Woodland Road" on most sat-navs and can be reached as described above.

Directions to Ushaw College:

From the South: Turn left off the A167 half a mile north of Neville's Cross traffic lights in Durham, by Sainsbury's Local, on to the minor road signposted Bearpark and Ushaw College. The College entrance is signposted to the right 2.5 miles along this road after the village of Bearpark.

From the North: Turn right off the A167 in Crossgate Moor, just past Durham Johnson School, on to the minor road signposted Bearpark and Ushaw College. The College entrance is signposted to the right 2.5 miles along this road after the village of Bearpark.

From Old Elvet. Heading towards the city centre on Old Elvet, turn left onto New Elvet. After 350 feet, bear right onto Church Street. At the traffic lights with the Bill Bryson University Library ahead of you, turn right onto Quarryheads Lane. At the first roundabout take the first exit onto Potters Bank up into Neville's Cross. At the traffic lights at the top of Potters Bank go straight across, follow the road down and turn left at the junction onto Neville's Cross Bank (A690). At the roundabout take the 2nd exit onto Broom Lane (B6302). After 2 miles, at the T junction, turn right onto Whitehouse Lane. At the top of Whitehouse Lane turn left onto Woodlands Road. The main entrance to Ushaw College is 0.8 miles on the right.
