Session 1: 10:30 - 12:00

William De Morgan: His Life and Tiles (Tile making, Glazing and Design Techniques)

Sarah Hardy: Director of the De Morgan Museum, De Morgan Foundation

William De Morgan was a mathematician, novelist and artist, initially working in stained glass before moving into ceramics in the 1870s. With his friend and collaborator William Morris, De Morgan was embedded in the British 'Arts and Crafts' movement, becoming the most celebrated ceramicist of his generation. His designs include plants, birds, animals, fantastical creatures, Islamic motifs and mathematical

patterns. He also experimented with glazing techniques, and championed the revival of metal-glazed lusterware.

Sarah' illustrated introduction to William De Morgan's tile design, and approach to making, will include handling tiles from the De Morgan Collection.

Sarah Hardy studied Art History at Durham University and the University of Manchester. She is a Victorian Arts & Crafts specialist, and has published research on William Morris's revival of embroidery, William Blake's influence on the Pre-Raphaelites, Bookbinding and the Kelmscott Press and (most recently) William De Morgan's use

of mathematics in his ceramic designs, for the De Morgan Foundation's touring exhibition, *Sublime Symmetry*.

Sarah's museum career began with education at the Fitzwilliam Museum in Cambridge, moving into interpretation at Helmshore Mills Textile Museum, Lady Lever Art Gallery, and Two Temple Place, followed by loans and exhibitions at the National Gallery and the British Library. She completed the Institute of Art and Law Diploma on Law and Collections Management prior to joining the De Morgan Foundation in 2018, where she is Director of the De Morgan Museum

Session 2: 12:00 - 13:15

Tulips and 'Arabesques': The Profound Inspiration of Islamic Art Models in Late Victorian Ceramics

In the 19th century, the decorative 'lure of the East' captivated several Western powers including England, France, Belgium and Italy, fostering a truly hybrid, crosscultural artistic blend of Islamic motifs with western technologies. In England, the

British Arts and Crafts movement, spearheaded by William Morris, William de Morgan and others, yielded exquisite ceramics and textiles inspired by Ottoman Iznik pottery, Iranian tiles and illuminated manuscripts.

This session will explore Late Victorian 'Islamic' style, focusing on ceramics, and identifying the key features distinguishing Morris and de Morgan creations from contemporary artists and designers, like Cantagalli and Samson. **Beatrice Campi** is an accomplished art specialist, multi-lingual professional auctioneer, and passionate researcher of Islamic and Indian art, experienced in cultural heritage. Formerly with Christie's auction house (London), in 2018 she moved to Chiswick Auctions, establishing their Islamic and Indian Art Department, handling thousands of artworks, until going freelance in 2023.

Her recent curatorial exhibition

collaborations include 'Water, Islam and Art' (MAO Museum; Turin, Italy), its twin travelling exhibition in Sharjah, UAE (2019-2021), and Persia Felix (MITA Museum in Brescia, Italy; March-July 2024). She regularly shares her research with both academic and non-specialist audiences, along with insights into Islamic metalwork, the ever-evolving art market trends, the history of legacy collections, differences and similarities between the Islamic and Western Art markets, and the intriguing world of art fakes and forgeries. Innovations in the Production and Decoration Methods of Victorian Tiles

This workshop will look at improvements in encaustic tile making, the invention of dustpressing clay tiles and new methods of transfer-printing that made the mass-production of Victorian tiles possible.



Hans van Lemmen taught art and design history at Leeds Polytechnic and Leeds Metropolitan University. His interest in tiles grew out of a study of Victorian architecture in Yorkshire and he is an avid tile collector who writes about the subject and has been involved in tile exhibitions in Britain and abroad.

Hans is the President of the Tiles and

Architectural Ceramics Society. His books include *Tiles in Architecture* (1993), *Delftware Tiles* (1997) and *5000 Years of Tiles* (2013).

Hans now lives and works in the Rosa Spier Huis community for retired artists and academics in the Netherlands.
