- 158 territorial disputes 1950-1997 (Blake)


Africa 41 East & Southeast Asia 22






Martinez's model of borderland development














World oil & gas basins and fields (1996 estimate)






Coal DepositsHotspots

Geological provinces with high hydrocarbon potential







An Exceptional Concentration of Hydrocarbons




Transboundary aquifers



- Argentina-Uruguay: construction of pulp mills on Uruguay *
- Costa Rica-Nicaragua: navigation and other activities on San Juan river *
- India-Pakistan: hydro-electric project on Kishenganga river **
- Turkmenistan-Uzbekistan: water-sharing on Amu Darya
- Nile basin states: water usage and allocation

* = dispute submitted to International Court of Justice** = dispute submitted to arbitration

The UN Charter and dispute resolution


Article 2

All members shall settle their international disputes by peaceful means in such a manner that international peace and security, and justice, are not endangered.

Article 33(1)

The parties to any dispute, the continuance of which is likely to endanger the maintenance of international peace and security, shall, first of all, seek a solution by negotiation, enquiry, mediation, conciliation, arbitration, judicial settlement, resort to regional agencies or arrangements, or other peaceful means of their own choice.






International agreements

- United Nations Convention on the Law of the Sea (1982/1994)
 - Part XV: Settlement of Disputes
 - Articles 74 & 83, paragraph 3:

Pending agreement ... the States concerned, in a spirit of understanding and cooperation, shall make every effort to enter into provisional arrangements of a practical nature and, during this transitional period, not to jeopardize or hamper the reaching of the final agreement. Such arrangements shall be without prejudice to the final delimitation.
