End of Fellowship Report

Graziana S. Ciola (ZKS- Lendrum Fellow, 2019)

Over the course of my appointment as ZKS-Lendrum Fellow at Durham University, I have pursued my research on the history of 14th century logic and science, with particular attention to the impact of Bishop de Bury's "Durham's Circle" on later developments in late medieval and early modern rational philosophy.

I have made extensive use of the Priory Library collection, focusing on late-13th and 14th century logical and scientific **manuscripts**, with particular regard to the following items:

Among these manuscripts, C.III.14, C.III.15, C.III.16, C.IV.17 and C.IV.19 have been digitised and are hence available online thank to the on the Priory Library Recreated project's website (https://www.durhampriory.ac.uk/list-of-digitised-durham-priory-library-books/). The accessibility of these texts and high quality of the digital images has made consultation easy and convenient and is proving a precious tool for my follow-up project as Lendrum Priory Library Residential Research Fellow, on the marginal annotations in these manuscripts.

This has enriched my main line of historical, logical and philosophical investigation.

Furthermore, I have organised a major international conference on the history of logic across different traditions (*Logical Validity Throughout History*, UCLA, May 2019) and I am currently co-editing the proceedings.

Overall, my career advancement, collaboration network and future projects have greatly benefitted from my experience as ZKS-Lendrum fellow at Durham University.

I have further established my profile as a leading researcher in my fields of specialisation. As a result, I have been invited to contribute to several forthcoming volumes on 14th century philosophy and logic (e.g. CUP, OUP, Brill) as well as to multiple international conferences (e.g. APA, San Francisco 2020; Philosophical Manuscripts, Moscow, 2020).

In Durham, I have had the possibility to engage in a regular and fruitful collaboration with Sara Uckelman (Philosophy). For example, over the summer, with the generous support of IMEMS small grant scheme and of DCAMP, we have organised a networking workshop to bring together all the UK based specialists in late medieval Latin logic – as well as dr. Mora Marquez (Gothenburg), to engage in further international

collaborations. The aim of the workshop was to draft a major grant proposal on rules of inference in late medieval logic, which we intend to submit to the AHRC in the near future.

I have also devised future collaborations with Giles Gaspers (History) and with Elsa Simonetti (Classics, now at KU Leuven).

During the course of my appointment in Durham, I have been short-short-listed for a tenure-track position in Medieval Philosophy at Université Laval, Quebec City; I have, furthermore, been awarded two prestigious two-year fellowships in medieval logic, respectively in Gothenburg and Nijmegen (*Radboud Excellence Initiative*). I have, thus, accepted the postdoctoral position in Nijmegen, where I will soon begin my new research project on late 14th century theories of consequences and their relevance for contemporary philosophy of logic.
